This technique (sometimes called a system breakdown structure) is used to define and organize the total scope of a project.



*Project Closure Phase is the last phase of the Project Life Cycle. The commencement of the Project Closure Phase is determined by the completion of all Project Objectives and acceptance of the end product by the customer. Closure of any financial issues, Collection and Completion of All Project Records and Archiving of All Project Records are typical elements of this phase.

The Inception phase is used to kick off a project; review the strategic direction of thebusiness; and confirm, document, and prioritize the high-level business requirements for the project. It is also the time to begin assembling and integrating the project team, to scope the entire engagement, and develop the initial project plan.
